**RE: Medicare Access and CHIP Reauthorization Act (HR 2)**

Dear Chairman Ryan and Ranking Member Levine:

The undersigned members of the Physician Clinical Registry Coalition would like to thank you for your leadership in the passage of H.R. 2, the Medicare Access and CHIP Reauthorization Act. We especially appreciate the inclusion of several provisions promoting provider participation in clinical data registries, including qualified clinical data registries. Providing registries with better access to Medicare data will enhance the ability of clinical data registries to track patients over time and better assess their clinical outcomes and need for follow-up treatment. Incorporating registry participation into the new Merit-Based Incentive Payment System (MIPS) will greatly improve the effectiveness of this new system and ensure that quality measures are specialty-specific and relevant for participating physicians. We also appreciate that the SGR bill provides a pathway for the development of alternative payment models that can utilize robust clinical information from specialty-specific clinical registries to reward physicians for providing the best possible patient care and improving health outcomes. Lastly, we applaud the requirement that the Secretary of Health and Human Services provide guidance on the application of the Common Rule to clinical data registries. The overlapping application of the Common Rule with the HIPAA privacy and security regulations to clinical data registries is highly confusing and sorely in need of clarification.
