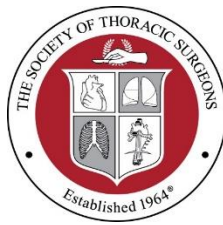

Re: S.1157/H.R.2319, the Women and Lung Cancer Research and Preventive Services Act of 2025

Dear Senators Smith and Moore Capito and Representatives Boyle and Fitzpatrick,

On behalf of The Society of Thoracic Surgeons (STS), I would like to thank you for reintroducing S.1157/H.R.4534, the Women and Lung Cancer Research and Preventive Services Act of 2025. This important legislation will accelerate research and investigate possible ways to decrease the number of women and underserved population affected by lung cancer, a cause to which our organization is deeply committed.

Founded in 1964, STS is a not-for-profit organization representing more than 7,900 surgeons, researchers, and allied healthcare professionals worldwide who are dedicated to ensuring the best possible outcomes for surgeries of the heart, lungs, and esophagus, as well as other surgical procedures within the chest.

STS commends you for seeking to accelerate the development of a national public education campaign on the importance of early detection of lung cancer in women. As you know, lung cancer is the leading cause of cancer death among women, and women face disparate rates of lung cancer compared to men. This gender difference is not well understood yet and is particularly stark among non-smokers: approximately two-thirds of non-smokers who are diagnosed with lung cancer are women. It is critical that we gain a solid understanding of women's access to and knowledge of preventive services, since covered services like low dose computed tomography screenings have proven effective. Your legislation is an important step towards utilizing all available data and best practices to save lives.

STS remains fully committed to improving the quality, safety, and efficiency of care for all patients. Research into and public awareness of lung cancer in women will benefit patients across the United States. We look forward to working with you on this issue.
