



# Training Manual Updates — Focused Review

#### Cancer

- Melanoma is a 'high-grade' skin cancer
- If occurred within 5 years of OR date, then code 'Yes' to Cancer (seq 500)

#### Hemodynamics

- Coding of values if not all values are available on the one test closest and prior to OR entry
- Left atrial appendage
  - Obliteration (OcarAAMeth seq 4139) versus amputation (OcarAAppAmp seq 4142)
  - If any part of the left atrial appendage is left in the body, then it is not considered to be amputated
  - Do not code both amputated and obliterated

#### Aorta Devices

- AVAVCompGrImplModelAo seg 5442
- Intended to capture commercial devices, not surgeon fashioned composites

#### TempYN2

- This is to be coded for ELS Model #5300 Physio Flex Annuloplasty Ring
- Leave blank if a mitral device was not inserted
- Answer 'No' if a mitral device was inserted but it was not an ELS Model #5300
- Do Not Use Temporary Fields unless instructed by STS to do so

#### Carpentier Fields

- DCF Should read 'Carpentier Type' not 'Carpentier Class' same meaning, but incorrect wording
  - i.e. Type I, not Class I

#### **Resolved Issues**

#### **ACSD Registry Configuration**

**STS-5057** - Corrected the issue of an invalid validation warning that appeared to end users, "Transcatheter replacement is marked Yes and Implant type is not marked Transcatheter device OR Mitral Leaflet Clip, these fields may be inconsistent" triggered for transcatheter device for 4.20.2 version

**STS-4731** - ACSD version 2.81 only - Operative Mortality critical error triggered incorrectly is now resolved

#### **ACSD Non-Analyzed Dashboard Report**

**STS-4068** - Incorrect display of drilled-down cases for ACSD Risk Adjusted Dashboard Report has been fixed in this release

**STS-4450** - Abstracted deep sternal wound infection was not populating in the ACSD Participant Dashboard report for a deep sternal wound infection, this issue has been fixed in this release

#### **ACSD MIPS Performance Measures Report**

**STS-5268** – MIPS Measures 226a and 226c (Tobacco Use: Screen and Cessation Intervention) has been updated the Performance Met criteria to include Former Smoker in the logic consideration

**STS-4363** – MIPS Report parameter page has been set to default to the 2020 reporting year to improve user efficiency and experience


