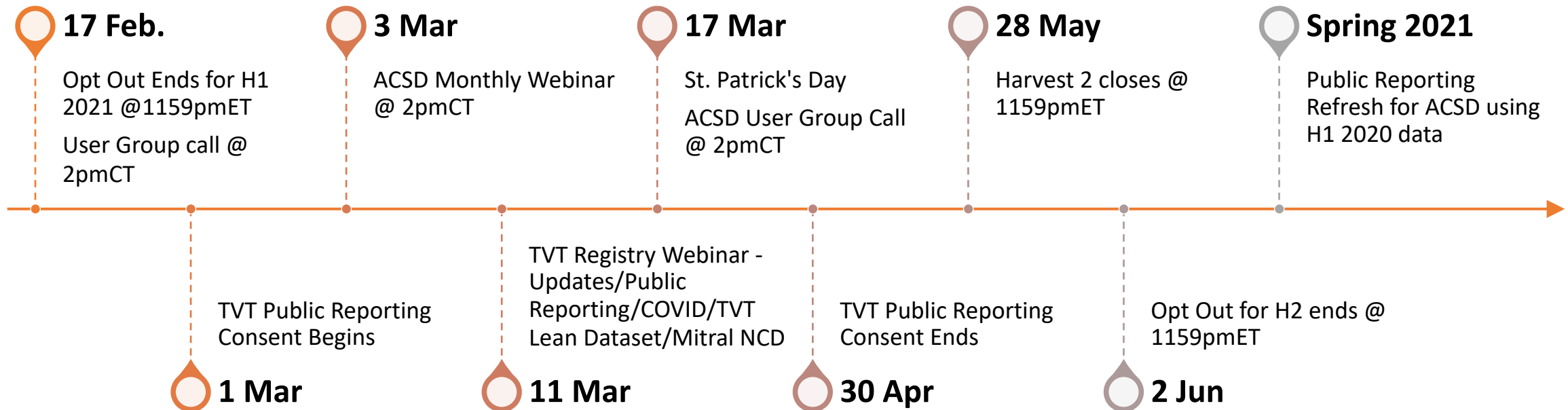

Platform Enhancements

Uploader / Data Quality Report

- STS-5522: Identified validations have been upgraded from an error severity to critical severity to improve the data quality within the STS database.
 - Critical errors will not allow invalid data elements or inconsistencies to be saved to the database.
 - Critical errors are required to be addressed in order for a record to save successfully to the database.

ACSD Risk Adjusted Benchmark Report

STS-5700: Identified calculations have been updated in the ACSD benchmark report. The updated calculations are listed below.

Number of Distal Anastomoses – Denominator update: Exclude records for which the number of arterial conduits and the number of vein grafts are both missing

Conduit Site Infection - Denominator update: Exclude patients with zero vein grafts or radial artery grafts

Renal Failure – Denominator update: Exclude patients with preop dialysis or preoperative creatinine ≥ 4.0

New Onset Atrial Fibrillation – Denominator update: Exclude patients with a history of Arrhythmia/ Atrial Fibrillation

Discharge Location - Denominator update: Exclude in-hospital mortalities

Discharge Medications – Denominator update: Exclude in-hospital mortalities

Cardiac Rehabilitation Referral – Denominator update: Exclude in-hospital mortalities and records for which cardiac rehabilitation referral was not applicable

ACSD Risk Adjusted Benchmark Report

ACSD Risk Adjusted Benchmark Report

STS-5708 – “Any infections” line is displaying as blank entries on the report.

STS-5721 – Preoperative Beta Blocker STS aggregate displaying lower than expected.

IQVIA Upcoming February 2021 Release Items

The following items are targeted for the weekend of February 27, 2021.

MIPS Performance Measure Report

STS-5696 – The MIPS report will exclude transcatheter and cancelled cases from the report denominator criteria.

STS-5814 – Updating exclusion criteria for patients identified as non-smoker and expired in the hospital

ACSD Non-Analyzed Dashboard Report

STS-5829 – ACSD Non-Analyzed Dashboard assigning cases for Mitral Valve replacement in the NONE category

STS-4942 – Updating the ACSD non-analyzed dashboard to exclude transcatheter valve procedures before PROC ID assignment is applied to cases.

STS-4262 – Operative Mortality variable option and calculations will be updated on the non-analyzed dashboard.

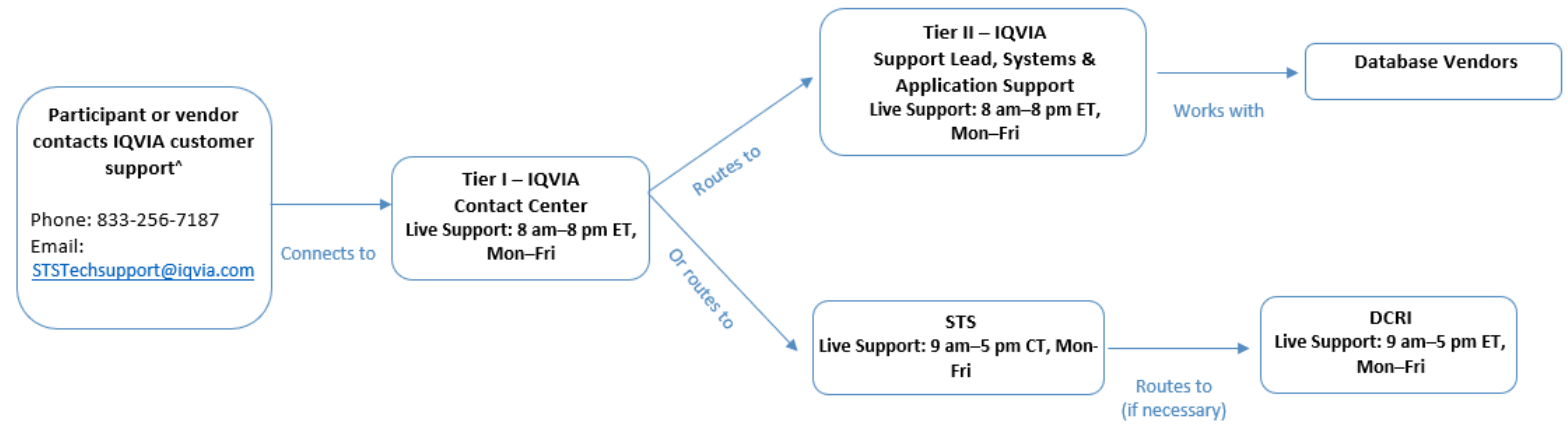
STS-5701 – Risk Score Match mismatches identified for specific records – calculation update required
