# 200 New Residency Slots Awarded to Hospitals Caring for Underserved Communities

On January 9, CMS announced the distribution of 200 Medicare-funded residency slots that were created as part of the Consolidated Appropriations Act. The additional residency slots were a policy priority of STS and heavily encouraged during its Advocacy Conference this past fall. These new slots are the first round of a proposed 1,000 positions, and most of this round focused on primary care and mental health specialties. Learn more about the distribution of the residencies.

# STS Encourages Data Collection for FDA Medical Devices Proposed Rule

In response to a request for feedback on the *Food and Drug Administration (FDA) Medical Devices; Voluntary Total Product Life Cycle Advisory Program Pilot Proposed Rule*, STS submitted a letter supporting the development and use of data collection systems—such as the robust STS National Database—to help ensure that patients, providers, and the FDA can make decisions based on the best available clinical evidence. The Society strongly encouraged the use of physician-led clinical data registries to capture real-world data for evidence generation. Read the letter.
