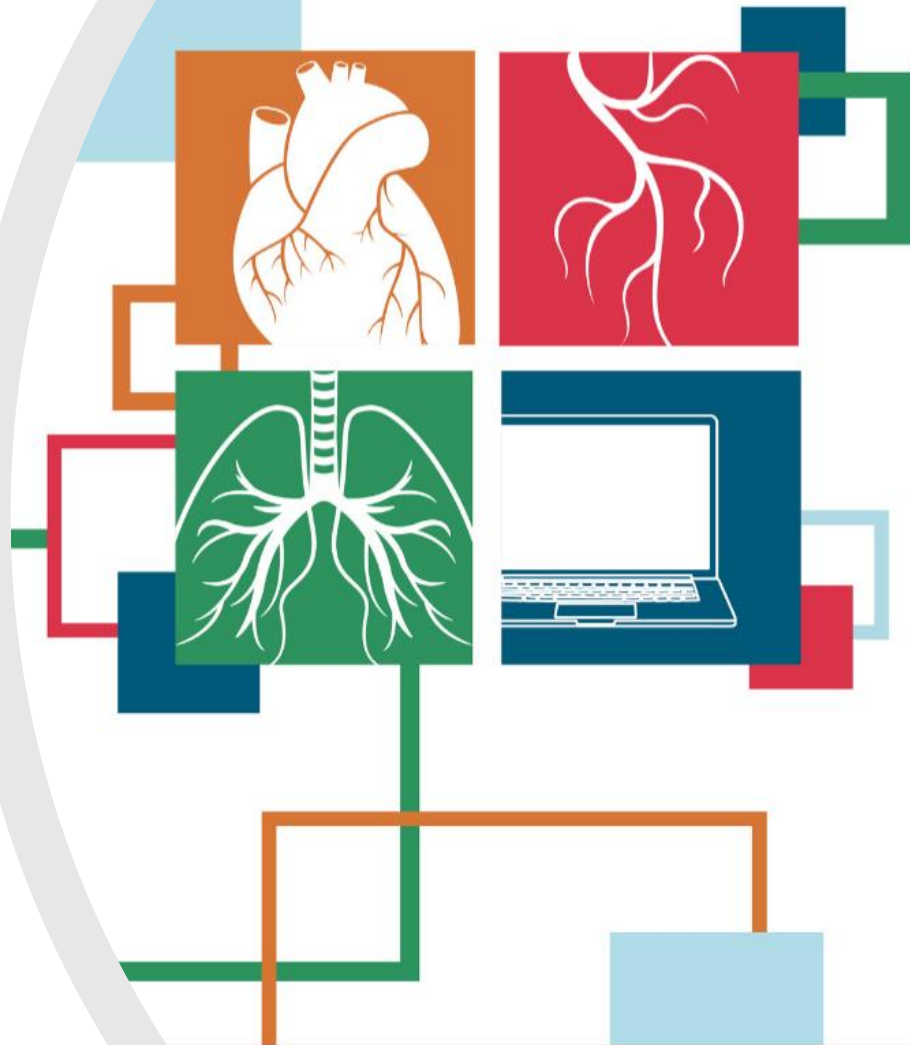

IQVIA Release Update

The item below were released on December 30, 2020.

NOTE: The following updates have been posted to the Notifications section in the platform.

Data Quality Report

STS-4993 – Additional warning validation messages were added to the DQR to alert users to review specific procedures that make up combination procedures. The additional warning validations are listed below:

2130 - **Superior Cavopulmonary anastomosis(es) + PA reconstruction

1275 - **Coarctation repair + VSD repair

1125 - **Arterial switch procedure and VSD repair + Aortic arch repair

All combo procedure warning validation messages are now added to the Data Quality Report. These are only warning messages and will not prevent records from saving to the data warehouse.

Missing Variable Report

STS-4383 - STS CHSD: MVR displays Secondary (Supplemental) Payor as missing variable when Primary Payer is 13(Charitable Care/Foundation Funding (internal)) or 14(Charitable Care/Foundation Funding (external))

STS-4508 - STS CHSD: MVR Displays DIAGNOSIS & PROCEDURE as missing variable when both 'MISSING' and another value are provided (this is primarily a migrated data scenario)

Resolved Issues

Uploader / Data Quality Report / Critical Summary Report

STS-5234 - Resolved the upload issue where the submission status displayed as cancelled or failed and users were unable to submit records.

STS-5317 - Submission cards not loading in uploader interface has been fixed in this release by updating in the backend and improvement in the performance.

STS-5201 - Fixed the issue of Uploader/DQR where the records from "Total Records" column of the Critical Summary tab does not match the number of records on the file (dat/input file). This issue is resolved.

Missing Variable Report

STS-5048 - Anesthesia variables were displaying as missing for sites that do not participate in the Anesthesia component has been fixed in this release.

STS-4606 - Resolved the issue where Index procedures that were not correctly assigned/categorized in the CHSD Participant Dashboard report.

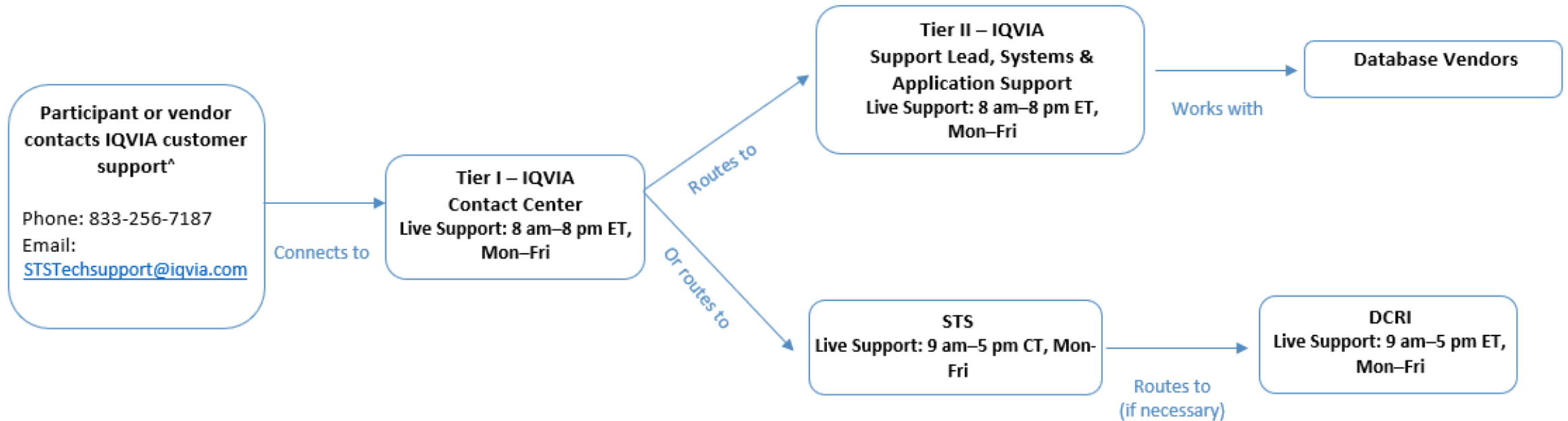
