

GTSD Data Manager Webinar – January 8, 2020

Question	Answer
Will IQVIA be able to handle any Demographic Data Version for GTSD and/or CHSD regardless of the Operative Data Version?	Yes, IQVIA will be able to handle demographic data versions prior to 2.41 and 2.3. However, IQVIA will only accept operation records with a data version of 2.3 forward.
What will become of any earlier than 2.3 data that we have submitted or get mortality information on?	Data that was previously submitted and housed at DCRI will be migrated over to the IQVIA Data Warehouse.
Also, will the older demographic data for operations in successive versions need to be reloaded to conform to 2.3 or 2.41?	No, IQVIA will be able to handle older demographic versions.
When will we be getting the login info email to be able to upload?	These emails will be sent to Participants the week of January 20 th .
Will there be a DQR companion guide?	Yes, there will be a user guide located in the “Library” of the IQVIA platform. There will also be “How To” videos available for assistance on navigating the DQR.
Before, the last file uploaded overwrote all others. Now I hear her saying to upload MANY files. Are we supposed to split up all of our cases so they only show up once?? I routinely have hundreds of cases. Thank you.	In order to get accustomed to the new data submission platform and DQR, we are suggesting Participants submit multiple smaller files in the beginning of the harvest period. If a record(s) is submitted multiple times, that record will be updated if any changes were made from the previous submission.
If multiple files are uploaded successfully, is each file appended to the others to achieve our complete data submission?	Correct. IF you submit 3 different files that include three different time periods, these three files will be used in analysis. P
What do the warning #'s mean? ex 1658, 796 etc	If you are referring to the numbers in the “Alerts By Records” section of the DQR, these are the number of errors/warnings found within that particular record.
Will user names and passwords be valid for both STS GTSD and STS Adult Cardiac? Or are different accounts needed?	Participants will have one user name and password. Your user name/password will allow you access to both GTSD and ACSD if you Participate in both databases.

<p>Will we be able to view information from the Fall Harvest '19 as of 1/22/19?</p>	<p>The STS Benchmarked data will be available, the site's benchmarked data will be updated and displayed with the next harvest.</p>
<p>Can you clarify what the February 14th 2020 deadline represents?</p>	<p>The February 14th deadline is the last day to submit data to the Data Warehouse for the Spring 2020 Harvest. In order to be included in the Spring 2020 Data Analysis and to be eligible to receive risk adjusted results, you must submit your data to the Data Warehouse no later than 11:59PM Eastern on 2/14/2020.</p>
