Dear Representative Pascrell:

The undersigned members of the Physician Clinical Registry Coalition thank you for introducing a bill to require the Secretary of Health and Human Services to issue guidance on the application of the Common Rule to clinical data registries. The Physician Clinical Registry Coalition (Coalition) represents 21 national medical specialty societies and other physician-led groups that sponsor clinical data registries that collect and analyze clinical outcomes data to identify best practices and improve patient care.

As you know, there are many areas of uncertainty with respect to the application of the Common Rule (and other equivalent federal regulations) to clinical data registries. At the same time, most clinical data registries are covered by the broader and more stringent protections for identifiable patient data under the HIPAA privacy and security rules. Your bill is a step in the right direction in directing the Secretary to clarify these areas of uncertainty and redundancy. We look forward to working with you and your staff to develop more specific directions for the Secretary in this area, particularly with respect to the overlapping and duplicative requirements of HIPAA and the Common Rule.
