Apply for a Scholarship to Attend the October STS Legislative Fly-In

The Society is offering four scholarships for STS members to attend the STS Legislative Fly-In on Monday, October 17, in Washington, DC. This Legislative Fly-In takes place during the American College of Surgeons Clinical Congress and will allow STS members to join their colleagues in advocating for issues specific to cardiothoracic surgery. Fly-In participants also will be able to attend an STS-hosted briefing for congressional staffers, focusing on the STS National Database and Medicare physician payment reform. The scholarships will cover reasonable travel and meal expenses (1 day/1 hotel night). Send your completed application, along with your CV, to advocacy@sts.org by September 2, 2016. Award decisions will be made by September 9.

Participate in the 2016 North American Jeopardy Competition

Similar to the popular television show, STS will host a Jeopardy competition at the STSA Annual Meeting in November. This challenging cognitive skills competition is for two-person teams of residents enrolled in an ACGME- and/or a Royal College of Physicians and Surgeons of Canada-approved thoracic surgery residency program. The winning North American team will compete against the winning European team for the Cardiothoracic Surgery Resident Jeopardy Competition - Champion title at the STS Annual Meeting in January.

Residents interested in participating must take an individual online screening exam between August 31 and September 7. You also must provide the name of your partner and upload a letter from your program director attesting to your eligibility and confirming that you will be able to attend the STSA Annual Meeting if selected as a finalist and the STS Annual Meeting if you should win the STSA competition. The six teams with the best combined scores from the online exam will attend the STSA Annual Meeting for the competition, with travel expenses paid by STS. The runners-up will each receive \$50 and the members of the winning North American team each will receive \$500.
